## ADDITIONAL TERMS AND CONDITIONS

The terms and conditions set forth below are an integral part of the order set forth on the previous contract between customer and D&P MULTIMEDIA , hereinafter referred to as D&P.

1. Deposits - Unless otherwise agreed herein, customer shall make a deposit of 1/3 of the total balance to retain D&P to perform the requested services (this order) for customer. Upon completion of this order, customer's deposit shall be applied to the total cost of the order.

If the customer shall cancel this order prior to the date of services rendered by D&P, customer's deposit / payments will not be returned and a \$150 Cancellation Fee will be added to this order.

2. Payment - Customer shall pay D&P in full the balance due a week before the day of the event. Should customer fail or refuse to pay for and accept delivery of this order within thirty (10) days of notification of its completion, the order shall be in default and D&P shall charge customer a default charge of one and one-half (1 1/2%) percent per month on the unpaid balance due (minimum monthly charge \$1.00) or the highest rates permitted by applicable local law (whichever amount is less) until the entire balance due is paid in full. In addition, no additional orders will be accepted until this order is paid in full and customer shall be liable for any necessary cost of collection.

Customer may pay total outstanding balance due at any time before the event without any prepayment penalty.

3. Negatives and Copyrights - Unless otherwise specifically agreed herein, D&P has the sole and exclusive right to apply for copyright protection for all or any part of this order. D&P shall have the exclusive right to edit the video taken in its sole discretion , time to completion of video will fall within normal industry standards which can range from 6-12 months.

4. Use of Video & Photos - Unless otherwise specifically agreed herein, D&P has the right to use the negative materials for the order and reproductions therefore for the purposes of creating samples, displaying samples of D&P work, entry in video & photo exhibitions and other contests, editorial or art displays and general displays for D&P.

5. Liability - In the event that this order cannot be completed due to an act of God, strikes, any labor disturbances, severe weather conditions of any type, riots or civil disturbances, action or regulation by any local, state or federal government agency any event considered a "force majeure", or any other act or event outside the control of D&P, liability to customer shall be limited to return of customers deposit.

Customer hereby holds D&P harmless of and from any liability for personal injury or property damage incurred at any event where D&P equipment is in use and as a result thereof.

6. Lighting and Equipment - The video taping of the event will be performed subject to the limitations of the D&P equipment. In the event of production equipment failure, D&P cannot be held liable by customer except to the extend of the monies paid by customer to D&P under the terms herein. D&P extends no warranty with regard to the quality/life of the video tape or Disc to customer other than that given en by the video tape manufacturer. D&P Is well equipped with backup & redundant equipment for essential equipment.

Customer acknowledges that lighting in the area of filming is essential to the quality of the final product of the video & photos. Customer will assist D&P in obtaining necessary permission from the appropriate authorities for the control of the lighting in the areas being used, including any artificial lighting deemed necessary by D&P. Customer will also assist in any necessary permission from appropriate authorities relative to placement/positioning of D&P equipment to insure maximum effect in taping a particular event. D&P is not responsible for any defect of flaw in the video taping caused by improper lighting and/or positioning of equipment out of the control of D&P as set forth above.

7. Miscellaneous - D&P is hereby retained as the sole and exclusive videographer/photographer to perform the services requested herein.. Customer shall take all necessary steps to insure that this provision is enforced. D&P reserves the right to make additional charges if the usage and purpose of this order is other than as indicated herein. This order is binding and may only be altered in writing by the parties. D&P is not responsible for any remarks made by persons being interviewed nor for the inability to access types of scenes or quality of scenes due to weather and external forces out of our control. Also, additional tapes will be produced at quality levels considered adequate for extra copies, in sole discretion of D&P.
